▶ It starts with primary care

If a member is considering gender-affirming surgery, the first thing they should do is visit their primary care physician – someone who not only understands their medical history but also knows them as a person.

▶ Connecting with a care team

From there, the primary care physician may introduce them to specialists and other caregivers familiar with the unique challenges of transitioning. Care teams collaborate to provide medical, psychological, and emotional support throughout the process.

▶ What's covered²

Based on medical necessity for the treatment of gender dysphoria, coverage for fully insured plan members includes mental health therapy, hormone therapy, gender-affirming upper- and lower-body surgeries, tracheal shave, and facial hair removal.
